CURRENT SITUATION							
Current Situation:	Suppression repair continues along the Highway 1 corridor, including but not limited to South Coast Ridge Road, McWay Ridge, Partington and Hermitage. The repair work along Highway 1 started near Big Sur and has progressed towards the south. As more equipment relocates to Highway 1 from the mountains tomorrow, repair work will begin near Pacific Valley and move north. It is expected that the suppression repair work along Highway 1 will be 75% completed by the end of this week. An infrared flight mission was flown yesterday which revealed a couple of hot-spots within the fire area that will be mitigated today. These areas were not on containment lines and do not pose a threat of fire spread outside the fires footprint. Some of these hotspots did produce visible smoke and are being monitored until they are addressed. The very warm temperatures will continue over the next few days with temperatures near 100 degrees inland and in the valleys. Over the weekend, northeast to east-northeast winds will allow for warm and dry air to downslope towards the coast, with poor humidity recoveries overnight especially inland. This will continue to expose hot spots which will be closely monitored and patrolled by fire crews.

Evacuation Warnings:	All evacuation orders have been lifted.						
National Forest:	The Los Padres National Forest will remain closed per Forest Order 05-07-51-20-22, and will remain closed until the Dolan Fire is declared out.						
Road Closures:	The Nacimiento-Ferguson Road is closed to all traffic From Highway 1 to the Fort Hunter Liggett Base boundary line. Los Burros Road and Plaskett Ridge Road are open to residents only. For more information visit https://roads.dot.ca.gov/
