DOLAN and COLEMAN FIRES

Saturday, October 25, 2020 9:00 AM

CLOSURE ORDER REMAINS IN EFFECT FOR THE MONTEREY RANGER DISTRICT

The Monterey Ranger District of the Los Padres NF remains closed under Closure Order Number 05-07-51-20-22. This closure order is in place to provide for visitor and firefighter safety. Additionally, emergency fire restrictions are in effect until October 30.

TODAY:

Coleman Fire

Low temps and higher humidity will allow for more direct line to be cut around the fire edge today.

Patrols will continue along the west side of the fire. Grader work is planned for the South Coast Ridge Road and Plaskett Ridge Road. On the Nacimiento-Fergusson Road crews continue to repair drainage control structures and cut downed trees as necessary. Suppression damage repair continues in the Cone Peak and Arroyo Seco areas.

YESTERDAY:

Coleman Fire

Crews continued mop-up and line construction resulting in an increase in the fires containment.

Dolan Fire

Crews on Highway 1 spotted one small smoke far interior on the fire yesterday. Dozers and graders continued with major repairs on the south and east sides of the fire. Suppression damage repair continued in the Cone Peak and Arroyo Seco areas.

WEATHER:

The sky will be mostly cloudy today, with high temps in the 60s and high relative humidity. Southwest winds, gusting to 15mph or more will continue through most of the day. Tomorrow evening we will see the air start to dry out again, with temps back into the 70s on Monday.

The Coleman fire started at approximately 1200 pm on October 18, 2020 and is estimated at 574 acres with 70% containment.

The Dolan Fire started on August 18, 2020 on the Monterey Ranger District of the Los Padres National Forest. The fire has grown to 124,924 acres and is 98% contained. The Monterey Ranger District remains under a Closure Order for visitor and firefighter safety. The Nacimiento-Fergusson Road remains closed.

There are no mandatory evacuations in effect for any portions of the Dolan or Coleman Fires.

CLOSURES:

- The Monterey Ranger District of the Los Padres NF remains closed under Closure Order Forest Order Number 05-07-51-20-22.
- Nacimiento-Ferguson RD is closed to all traffic (public and residential) from Highway 1 to the Fort Hunter Liggett base boundary line (16 miles inland).

A Temporary Flight Restriction (TFR) is in place above the Coleman and Dolan fire area.
